The 12-day trip was filled with opportunities to learn about various aspects of agriculture, politics, and culture in Germany and Czechia. The group attended Agritechnica in Hanover, which is the world's largest trade fair for ag machinery and technology. Then, they explored key historical sites in Berlin, such as the Brandenburg Gate, Berlin Wall, Checkpoint Charlie, and Alexanderplatz. In Dresden, the group reconnected with our college partners at the University of Cooperative Education who were wonderful hosts and*

tour guides through not only the beautiful downtown Dresden, but also a modern dairy facility, a flour mill, and state-of-the-art equine breeding and riding venue in Moritzburg. At the Saxon Parliament, the group met with parliament members, Sandra Gockel and Thomas Schmidt, as well as the State Minister for the Environment and Agriculture, Georg-Ludwig von Breitenbuch. The trip concluded with a visit to Prague, where students deepened their understanding of the region's history, architecture, and cultural heritage. After mastering public transportation, navigating language barriers, paying in foreign currencies, and enjoying wonderful cuisine, the group headed home just in time for Thanksgiving with their families.
